AMENDMENT OF THE RULES AND REGULATIONS FOR CHANDLER PLACE CONDOMINIUMS

THIS AMENDMENT to the Rules and Regulations for Chandler Place Condominiums is made this 28th day of November, 2022 by the Chandler Place Condominiums Homeowners Association, Inc. (hereinafter, "the Association").

### WITNESSETH:

THAT WHEREAS, the Association caused to be recorded its Rules and Regulations Revision dated August 28, 2015 in Book 016173, PG 00971-00988 of the Wake County Registry; and,

WHEREAS, in accordance with GS 47C-3-102(1) the Board of Directors of the Association is authorized to adopt and amend its Rules and Regulations concerning the use of its Common Elements; and,

WHEREAS, Article III of these Rules and Regulations provide for "Selling, Leasing and Moving Procedures" as found at Book 016173, PG 00973-00975 of the Wake County Registry; and,

WHEREAS, in the fourth paragraph of said procedures, found at Book 016173, PG 00974 of the Wake County Registry, a nonrefundable administrative fee of \$250.00 is required of each party moving out or in the Chandler Place Condominiums; and,

WHEREAS, the Board of Directors of the Association, having determined this fee is no longer sufficient, desires to increase this fee by \$100.00 to more adequately defray the Association's costs of parties moving out of or into Chandler Place Condominiums:

NOW, THEREFORE, the undersigned does hereby declare that the Rules and Regulations of the Association are amended as follows:

Paragraph four of Article III of the Association's Rules and Regulations governing "Selling, Leasing and Moving Procedures" is revised to read as follows:

... "Each party moving out or in must first pay a \$350.00 nonrefundable administrative fee to the Property Manager. Owners of any unit being moved out of or into are primarily responsible for payment of the fee and all damages that may be reasonably attributed to the moving process"....

With an effective date of January 1, 2023, this amendment was ratified by a unanimous vote of the Association's Board of Directors at its November 28, 2022 regularly scheduled meeting, with a quorum being present.
